Accident Waiver and Release of Liability- I acknowledge that attendance at Sierra Canyon School in an event that involves risk especially during a pandemic. I acknowledge that this Accident Waiver and Release of Liability form will be used by the venue and Sierra Canvon School and will govern my actions and responsibilities at this event.

Assumption of Risk - The parent/guardian and student assume any and all risks, known or unknown, which may exist as a result of the student's participation in Hack the Valley, including, but not limited to traveling to Hack the Valley, attendance and participation at Hack the Valley and traveling from Hack the Valley.
